### SUPPORT COORDINATION

#### **Program Highlights**

- Linkage to Supports and Services
- Individual budgets are based on assessed level of need with which individuals can purchase goods and support services on a fee-for-service basis.
- Flexibility to choose options and services that best meet individual needs
- Access to a Support Coordinator(SC) to assist in developing an Individualized Service Plan (ISP)
- Person-Centered Planning
- Strength Based Approach
- Advocacy
- Case Management
- Partnerships with individuals, families, and team

#### Planning Process & Access to Services

- Individuals will be assigned a Support Coordinator (SC).
- The SC will complete a Person Centered Planning Tool (PCPT) with the individual, their family, and team to gather information and identify strengths.
- The SC will coordinate and facilitate team meetings to identify service needs and develop the ISP.
- The SC will explore and link the individual to appropriate services.
- Waiver Assurance Coordinators (DDD staff) will approve the plan, authorize the service, and provide quality assurance.
- The SC will provide quality case management and maintain phone and faceto-face contact with the individual and their support team, as well as with the providers to ensure that the ISP and services are being delivered appropriately.



#### WHO CAN RECEIVE SERVICES?

*In order to be eligible for Support Coordination services, individuals must:* 

- ♦ Be a resident of New Jersey
- ♦ Be 21 or older
- DDD and Medicaid Eligible
- ♦ Meet Functional Criteria
- Live in their own home or with their family
- Not on the Community Care Waiver (CCW) simultaneously

In order to be eligible and remain eligible for services through the Support Coordination Program, you must ensure that your Medicaid status remains active.
